- Halloween contest submit pumpkin pictures between 10/10 and 10/29. Drawing for Creative/Funny/Scary pumpkin will happen on 10/30
- Budget discussion
 - o Today we have \$20k+ in surplus in our operating account
 - Would like to maintain one year of surplus which is about \$8k, so we have way more than we need
 - Proposing \$100 dues (\$20 reduction)
 - Last thing we want to do is reduce and then increase again, but based on trends today, we could easily keep this \$100 dues amount for 5 years and re-assess at that point
 - Discussed options for using extra money for sidewalk plowing, etc. homeowners were generally against this option as it would likely be pricey, and most homeowners are ok managing their own sidewalks
- Nominations for board spot
 - No nominations at this point (suggestion was raised to involve new homeowners)
 - We will send communication asking for nominations, but please reach out to neighbors and/or the board if you have suggestions or nominees
- Winter sidewalk and maintenance discussion
 - All but 2-3 homes did a great job of maintaining their sidewalks last winter
 - There were volunteers in the meeting that offered to help shovel/plow if needed when homeowners are out of town.

 As we did toward the end of last year, the board will work with the city if there are issues this year since it is a city ordinance to clear your sidewalk.

G. Homeowner questions

- Monument refresh
 - Mulch and plants in the spring (Katie)
 - Fall decorations (Hayley)
 - Need new lights next year's budget
- Jellyfish lights (and similar companies)
 - Are these ok? Do they need approval? (no, they do not since they are hidden from view)
 - That said, if the lights become inappropriately used (i.e. multi-color all year long) then it would be an issue we would need to address
 - o How much are these? It varies, but likely a few thousand dollars each.
- Solar panels
 - Do we need an approval from the board? Yes. The rules were updated a little over a
 year ago to include specifications for solar panels. Every solar panel company we've
 worked with is aware of such rules and shouldn't have a problem.
- Tree swap
 - o If I'm swapping a tree for the same tree, do I need approval? No, as long as it's one-for-one, you do not need board approval.
